### Net-zero emissions pathway ETFs (Formerly Low CO<sub>2</sub> ETFs)

Aims to address carbon risk and opportunities by seeking to achieve net-zero emissions by 2050 through a financed greenhouse gas emissions reduction pathway.

These ETFs invest in the vast majority of sectors, including energy. Organizations that play a part in producing tobacco, thermal coal or unconventional weapons, or whose ESG practices are deemed deficient, are excluded.<sup>5</sup>

### Fossil Fuel Reserves Free ETF

Aims to mitigate energy transition risk by excluding organizations that own fossil fuel reserves, are categorized in the fossil fuel sector or earn a significant share of revenues from fossil fuels.

Organizations that play a part in producing tobacco, thermal coal or unconventional weapons, or whose ESG practices are deemed deficient, are also excluded.<sup>6</sup>

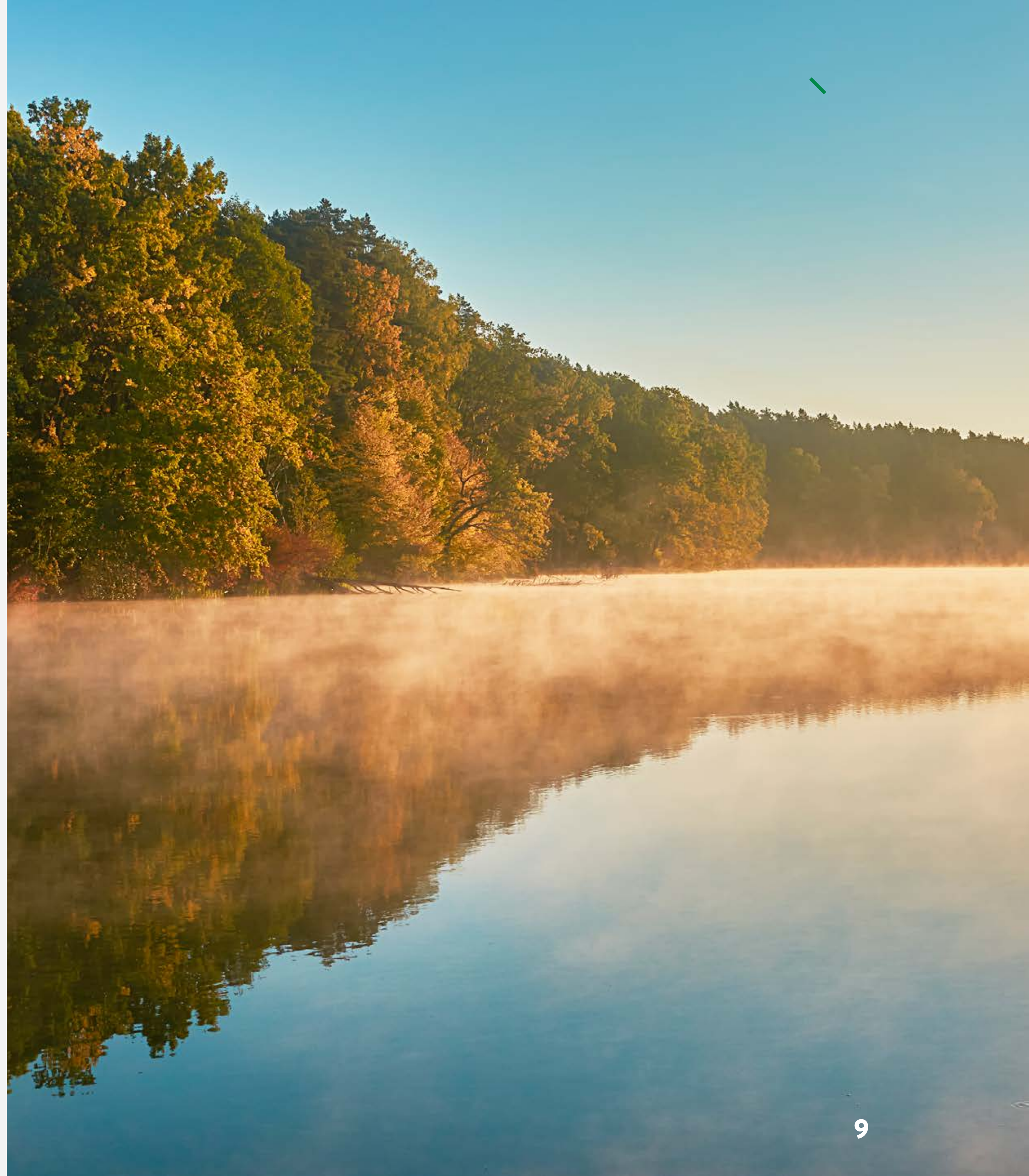
### SocieTerra ETF

Aims to invest in organizations that:

- Implement sound ESG practices throughout their operations
- Are improving their ESG practices, notably following a shareholder engagement process

Organizations in the production and dedicated transport of fossil fuels, civilian firearms, nuclear and coal energy and tobacco industry are excluded.<sup>7</sup>
